The possibility of obtaining grants is being looked into. The City would need to be the applicant and Sean and Jeff would do the legwork. Council was in agreement to apply for grants with the City being the applicant.

Baseball Field Improvements

A high school civics class presented a proposal to make improvements to the baseball park. The students would like to improve the infield and outfield. The class would also like to do improvements to the bleachers, concession/bathroom building and the swing set. The possibility of a new scoreboard was also discussed. If improvements would be done to the field, it would need to be completed before May since rec baseball starts and the field will be in use. It was then decided to focus on the other items and not worry about the baseball field itself. Council gave their support for the improvements.

Police Department Report

Police Chief Cole Dinkel gave his department report. Chief Dinkel is still working with the county on purchasing the outer body vests. There is also a crack in the windshield of the Durango patrol vehicle. He will see about getting it replaced.

City Superintendent Report

City Superintendent Brad Schmidtberger gave his department report. The south end of the Cathedral Street water project is completed and the construction company is moving north. The street replacement for Cathedral Street is scheduled to begin February 28, 2022. Both of the City pickups are being repaired.
